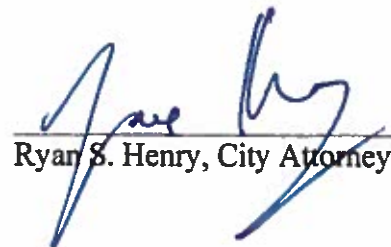
V. ADJOURNMENT
