ORDINANCE NO. 2014-*(O)**

AN ORDINANCE AMENDING CHAPTER 109, SIGNS, OF THE CODE OF ORDINANCES BY REPEALING CURRENT SUBSECTIONS 109-19 (d) (1) a.-f. PERTAINING TO THE PLACEMENT OF SIGNS ON PUBLIC PROPERTY AND AMENDING SUBSECTION 109-19 (d) (2) TO CLARIFY THE TYPE OF ELECTION AUTHORIZED.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WINDCREST, TEXAS that Chapter 109, Signs, is amended by repealing current Subsections 109-19 (d) (1) a.-f. and by renumbering current g. to a., h. to b. and i. to c.

BE IT FURTHERMORE ORDAINED BY THE CITY COUNCIL OF THE CITY OF WINDCREST, TEXAS that Chapter 109, Signs, is amended by revising subsection 109-19 (d) (2) to read as follows:

“(2) Such signs must relate to a scheduled City of Windcrest, Northeast School Board or Bexar County Water Control and Improvement District No. 10 election or an event held by a church or non-profit organization located within the City of Windcrest and may not be erected, used or installed more than twenty (20) days preceding the commencement of early voting for the election or twenty (20) days preceding the church or non-profit organization event to which the sign pertains and shall be removed no later than forty-eight (48) hours after the conclusion of the election or the event to which the sign pertains. Such signs may not exceed four (4) square feet in area. Such signs may not be illuminated or have any moving elements, or extend over sidewalks or driveways.

This ordinance shall take effect five (5) days after publication of its caption.
